**KINDERGARTEN REGISTRATION**  
**2020 - 2021 School Year**

The Northvale Public School will be registering students who are eligible for kindergarten during the 2020-2021 school year. The eligibility requirements are as follows:

1. The child must be five years of age on or before October 1, 2020. Proof of above must be furnished at the time of registration.
2. Physical Form – completed by physician
  - A current physical should be submitted upon registration.
  - If physical was not performed within the 365 days from the start of the school year, a new one must be submitted immediately upon completion.
3. Immunization Form – completed by physician
  - A current immunization record must be submitted at registration, regardless of physical exam date.
  - Any subsequent immunization data should also be submitted immediately upon completion.

The following immunizations must be completed by September 2, 2020.

D.P.T.	4 doses with one being at age 4 or 5
Polio	3 doses with one being at age 4 or 5
Measles	2 doses
Mumps	
Rubella	
Varicella	1 dose
Hepatitis B	3 doses

4. Proof of Residency:

The District shall accept a combination of documentation to demonstrate a student's eligibility for enrollment in the District. The District requires at least three (3) proofs of residency and at least one (1) document demonstrating proof of the child's identity and date of birth. The following list of documents are *examples* of documentation accepted by the District. The District will not require the disclosure of any of these documents as a condition of enrollment, and all eligible students will be admitted into the District provided that the documentation submitted is sufficient to demonstrate residency.

Proof of Residency (Examples)

- a. Deed or Lease
- b. Utility bill
- c. Bank or mortgage statement
- d. Vehicle Registration
- e. Driver's license or passport
- f. Property tax bill
- g. Notarized, signed letter from landlord

Proof of Child's Date of Birth

- a. Original or certified copy of birth certificate
- b. Passport
- c. Other proof of age and identity deemed sufficient by the District

If you have a kindergarten-age child, please complete and return the form on the bottom of this page along with all the required documents to Mrs. Rudolph, School Secretary, before February 7, 2020. If you know of someone who has a child who will be five years old prior to October 1, 2020, please forward this notice to them for completion.
